Intercommunal Waste Treatment Complex ProNatura Sp. z o. o. asks for to submit a price offer, taking into account the following requirements:

1. Order name: **Supply of filling to the scrubber**
2. The subject of the order is: delivery of 65 m<sup>3</sup> of SNOWFLAKE type plastic rings, filling one scrubber. The rings will be delivered by the Contractor in bags or other packaging convenient for the Contractor to perform the delivery in the amount of 65 m<sup>3</sup>. The offered rings must meet the following technical parameters:

- Type: SNOWFLAKE (drawing as below)



- Material: PP (polypropylene),
- Diameter: 90mm
- Bulk density: 45 - 51 kg/m<sup>3</sup>
- Specific area: over 90 m<sup>2</sup>
- Void factor: 97%
- Number of pieces in 1 m<sup>3</sup>: 5000 – 5500
- Operating temperature: minimum 65 °C

3. Deadline for order completion: no later than May 19, 2024. The order is expected to be completed in April-May 2024. DDP (Delivery Duty Paid) delivery required - including all transport costs, customs duties and taxes. Delivery details and dates will be agreed by phone and e-mail.
4. Offer evaluation criterion: 100% price  
The final price must include all costs, including delivery costs, customs and taxes.
5. Payment term: 100% of remuneration payable within 30 days after the conclusion of the contract.
