Pursuant to the art. 6.5 of the Specification of Terms of Reference, Instruction for Economic Operators, TOM I_IDW_EZP.270.23.2022, the Awarding Entity, agrees to carry out a site inspection, as requested. However, for organizational reasons the site inspection cannot be held at the proposed date.
