# Information on selecting the most advantageous offer

Refers to: public procurement procedure conducted in the basic procedure without negotiations for the supply of a higher class passenger car – 2 parts, case number 22/ZP/24.

Ladies and Gentlemen,

Acting pursuant to Article 253 section 2 of the Act of 11 September 2019 – Public Procurement Law (Journal of Laws of 2024, item 1320), hereinafter referred to as the "Act", the contracting authority hereby informs that in this procedure:

#### Part I

- pursuant to Article 239 section 1 of the Act, he selected offer no. 1 submitted by the contractor LOUYET Brussels (Chaussée de Louvain 864, 1140 Brussels), as the most advantageous:
- 1) Price criterion the contractor offered EUR 72,855.20;
- 2) Warranty on the motor and mechanical, electrical and electronic components and additional equipment – the contractor offered delivery within 36 months;
- 3) Body paint coating warranty the contractor offered delivery within 36 months;
- 4) **Perforation of body components warranty** the contractor offered delivery within 144 months.

#### **Justification**

The offer of the above-mentioned contractor represents the best value for money. The offer was considered the most advantageous and received 90 points, i.e. in:

- price criterion 55.00 points,
- criterion warranty on the motor and mechanical, electrical and electronic components and additional equipment – 10.00 points,
- criterion body paint coating warranty 10.00 points,
- criterion perforation of body components warranty 15.00 points,

in accordance with the description of the criteria and method of evaluating the offers, contained in the specification of the order conditions.

Pursuant to Article 239 paragraph 1 of the Act, the contracting authority selects the most advantageous offer based on the offer evaluation criteria specified in the procurement documents.

#### Part II

- pursuant to Article 239 section 1 of the Act, he selected offer no. 1 submitted by the contractor LOUYET Brussels(Chaussée de Louvain 864, 1140 Brussels), as the most advantageous:
- 1) Price criterion the contractor offered EUR 37,633.94;
- Warranty on the motor and mechanical, electrical and electronic components and additional equipment – the contractor offered delivery within 36 months;
- 3) Body paint coating warranty the contractor offered delivery within 36 months;
- 4) **Perforation of body components warranty** the contractor offered delivery within 144 months.

### **Justification**

The offer of the above-mentioned contractor represents the best value for money. The offer was considered the most advantageous and received 90.00 points, i.e. in:

- price criterion 55.00 points,
- criterion warranty on the motor and mechanical, electrical and electronic components and additional equipment – 10.00 points,
- criterion body paint coating warranty 10.00 points,
- criterion perforation of body components warranty 15.00 points,

in accordance with the description of the criteria and method of evaluating the offers, contained in the specification of the order conditions.

Pursuant to Article 239 paragraph 1 of the Act, the contracting authority selects the most advantageous offer based on the offer evaluation criteria specified in the procurement documents.

In the procedure in question, the contracting authority assessed the offer according to the following criteria:

#### Part I

# Price criterion:

PRICE criterion (C) – weight 55 points (%), calculated according to the contractor's declaration, in accordance with the Bid Form;

#### NON-PRICE CRITERION:

Warranty on the motor and mechanical, electrical and electronic components and additional equipment criterion – weight of 10 points (%), calculated according to the contractor's declaration, in accordance with the Bid Form:

**Body paint coating warranty** criterion – weight of 10 points (%), calculated according to the contractor's declaration, in accordance with the Bid Form:

**Perforation of body components warranty** criterion – weight of 15 points (%), calculated according to the contractor's declaration, in accordance with the Contractor Form.

#### Part II

#### Price criterion:

PRICE criterion (C) – weight 55 points (%), calculated according to the contractor's declaration, in accordance with the Bid Form;

# **NON-PRICE CRITERION:**

Warranty on the motor and mechanical, electrical and electronic components and additional equipment criterion – weight of 10 points (%), calculated according to the contractor's declaration, in accordance with the Bid Form;

Body paint coating warranty criterion – weight of 10 points (%), calculated according to the contractor's declaration, in accordance with the Bid Form;

**Perforation of body components warranty** criterion – weight of 15 points (%), calculated according to the contractor's declaration, in accordance with the Contractor Form.
